
Attached is Gowlings' Supreme Court of Canada Bulletin confirming dismissal of the TWU application for leave.

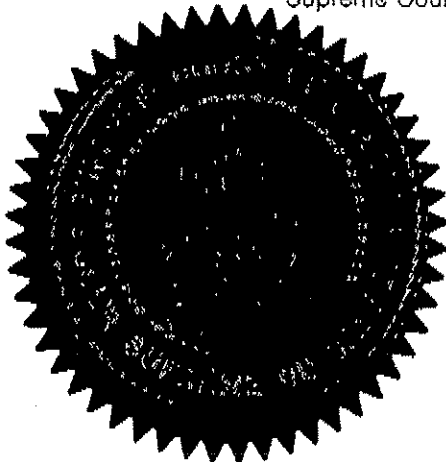
